AICC INC. RULES RELATING TO REGISTERING OF SUFFIXES

- 1:** Every Breeder Is Required To Register A Cattery Prefix With A Recognized Governing Body Whether It Be In The State They Reside Or A National Body.
- 2:** Four Names (4) Names Are To Be Submitted In Order Of Preference On The Application Form And Returned To The Registrar With The Prescribed Fee. Select All Names Carefully As Once Prefixes Have Been Checked And Approved They Will Not Be Changed. Please Note Holders Of Suffixes Who Change Their Names By Marriage Or Deed Poll Must Notify The Registrar, However The Prefix Itself Cannot Be Changed.
- 3:** If Applying For An Experimental Suffix, The Experimental Program Must Be Approved Before The Suffix Is Applied For.
- 4:** All Words Used As Suffixes Must Be Registered.
- 5:** No Breeder May Apply A Prefix To A Cats Name Without First Having The Prefix Registered.
- 6:** No Breeder May Knowingly Use A Suffix of another Breeder either As A Suffix or In the *Common Name of the Cat* (Unless Given Permission From The Said Breeder).
- 7:** A Registered Suffix Is Not Transferable.
- 8:** Aicc Inc. Offers Lifetime Registration
- 9:** Failure to Fulfill Any of the Provisions of the Aicc Inc. Breeders Code of Ethics, Sign the Current Agreement And Pay The Prescribed Fee May Preclude The Breeders From Using The Services Of The Aicc Inc. Please Note Payment Of The Breeders Suffix Registration Fees Do Not Constitute Membership of Aicc Inc.
- 10:** Australian Independent Cat Council Inc. Rules Apply To The Registration Of Suffixes.
- 11:** Use Of A Suffix Shall Lapse On The Death Of The Holder And Shall Not Be Used Again For Twenty (20) Years.
- 12:** Should A Breeder Decide To Cease Breeding, The Suffix May Lapsed On Written Application To The Registrar. Such Suffix Is Not To Be Used Again By Another Breeder For Twenty (20) Years.
- 13:** All Queens Must Be Registered With Aicc Inc. Before A Litter Can Be Registered From Them.
- 14:** If Under 18 Years of Age A Parent/Guardian Must Co-Sign This Application, Accepting Responsibility for Liabilities

Under This Suffix and Also Agree and Abide By the Code of Ethics.

15: People Applying For A Suffix With Aicc Inc. Must State What Cat They Wish To Breed. It Is Our Policy That No Breeder Is To Supply A Cat/Kitten To A Person For The Purposes Of Breeding Unless They Are A Registered Breeder, Holding A Prefix/Suffix And A Current Membership Of A Registering Body.
